Did you know?



Dogs Feel Envy - If you have more than one dog, you may have noticed that one will act perturbed when the other one is receiving treats or attention. A study done at the University of Vienna had dogs perform an easy trick for a food treat, only after a period of time, only one dog in the group would receive the reward. The other dog would not only refuse to keep doing the trick but also showed signs of stress. When they repeated the experiment with just one dog in the room, that dog would keep doing the trick for a longer period after the treats stopped coming. This indicates that dogs *do* feel some form of jealousy



Small dogs live longer

Smaller dogs tend to live longer than bigger dogs, and that's because larger dogs age faster. Within one study, large dogs were found to have a median lifespan of 13.38 years, while the median for small dogs was 14.95.



Dog owners live longer Not only do dog owners tend to live longer than people without dogs, dog owners are also more likely to survive and recover from major health events, such as heart attack or stroke. Why? "Interacting with dogs can boost your production of 'happy hormones' such as oxytocin, serotonin and dopamine," says the American Heart Association. "This can lead to a greater sense of well-being and help lower levels of the stress hormone cortisol. And having a dog can help lower blood pressure and cholesterol, ease depression and improve fitness.

Something else to watch out for –
Meat Absorbent Pads

This was reprinted from a Facebook post by Joan Costello as relayed by a member of the Daytona Beach Obedience Club. It was suggested by Dianne Strickland –

“Last night I made chicken. When you buy at the store it comes in a styrofoam tray lined with an absorbent pad.

I took the tray and pad and put into another bag and put in trash....this am Elektra tattled and brought me the styrofoam tray. I ran upstairs and found they (Luna , Elektra and Zsa Zsa) had pulled the bag out of trash and the pad was missingI started googling and found out the gel in pad was nontoxic however it keeps expanding with fluid.

A call to poison control said if it had been within 2 hours, I needed to induce vomiting as the gel could expand and cause obstruction/ possible death. Since I wasn't sure which one was totally responsible so I was told to treat all suspects. I gave peroxide to the three suspects. Then we waited on the porch.....pretty soon I knew who ate most of the gel pad and already it had expanded to about the size of a basketball (like 20 x bigger than the gel pad). This was a danger I had never realized. In future I will bag and immediately take outside to trash can. All the girls are fine now and looking for more mischief.”

Something to be aware of for those who have garbage and/or counter surfers.

Another Thing to Consider when buying Dog Treats



Hey, it's Mike!, Happy Wednesday.

Today, I'd like to share a crazy thing I witnessed the other day at a pet food store near my home. I was standing in the check out line near one of those BULK pet food "stations". You know, the ones that look a lot like salad bars you see at people food restaurants.

Anyway, the store was selling all kinds of unpackaged pet food and pet treats... laid out "buffet style" in open trays and bins. And I couldn't believe what I was seeing. I watched in horror as a customer picked and poked her way through dozens of bulk food items...Picking up pig ears with her bare hands, grabbing the plastic tongs to gather other treats and scooping up different kinds of kibble. Even more dreadful... She stooped down to offer her pet a chance to sniff and lick a few of the dog treats she held in her fingers.

But get this...

The worst part was watching her place those same, now contaminated treats her dog had just licked... back into those same open bins. The whole experience was shocking. Why am I telling you about this?

Because watching this whole thing reminded me of just how risky it is to buy dog food and dog treats in bulk from open bins.

And I hope that after reading today's email, you'll at least think twice before you buy bulk food products for your dog.

That's because...Bulk items like these are nowhere near being fresh. They sit out all day in open bins, exposed to the air.

Which means...

They quickly become oxidized and lose much of their nutritional value, as each hour ticks by.

In addition, they're far more likely to be contaminated with dangerous, disease-causing bacteria. Like Salmonella and Listeria...As shoppers touch other high-risk items in nearby bins.

And think about this...

Bulk items have no labels. No batch numbers. No expiration dates. And no manufacturing or safety information.

So, there's no way to know where they came from. Which countries made them. Or what safety standards were followed. They could even be imported from China, or other countries known for their inferior food quality standards. Or preserved with BHA or cancer-causing chemicals.

And you'd never even know it.

Here's the point.

I've never been a fan of bulk dog food and treats. Which is why I've never recommended unpackaged products like these to safety minded dog parents.

They're simply too risky.
