Classes will be assigned after entries close, providing limits have not been reached from Regular and Optional entries

NOTE: Classes will run in Jump Height Order — Low to High Both Days

UDX Class - When entries are limited in the Open B and /or Utility B classes, a club must designate a UDX class in the premium list. Dogs entered in this UDX class would be entered in both Open B and Utility B, and the combined entry fee for these two classes must be paid. Once the limit has been reached in either the Open B or the Utility B class, the UDX class will be considered closed and any subsequent entries for this class will be unacceptable in their entirety.

RAE and RACH Class When entries are limited, a club must designate an RAE and a Rally Champion (RACH) class in the premium list. Dogs entered in the RAE class would be entered in both Advanced B and Excellent B, and the combined entry fee for these two classes must be paid. If due to entry limits an exhibitor cannot be entered in both the Advanced B and Excellent B classes the RAE class will be considered closed and any subsequent entries for this class will be unacceptable in their entirety. Dogs entered in the RACH class would be entered in Advanced B, Excellent B and the Master class. The combined entry fee for these three classes must be paid. If due to entry limits an exhibitor cannot be entered in the Advanced B, Excellent B and Master classes the RACH class will be considered closed and any subsequent entries for this class will be unacceptable in their entirety.

All entries must be legible and have a jump height if entered in classes that use jumps or it will be refused.

Note: Highest means Highest Scoring. Dog means either sex. Entries in Non-Regular classes are only eligible for non-regular class awards. No trophies will be shipped. All trophies not awarded or claimed before 5 PM on Sunday become property of the K-9 Obedience Club of Jacksonville, FL. Inc. Persons claiming prizes may be required to show an armband for identification. In the event of a tie, those in the running for the Highest Scoring Junior in All Regular Classes will participate in a traditional "Heel Free" run-off.

NOTICE TO EXHIBITORS

CLOSING DATE for entries is Noon. Wednesday, April 16, 2025 after which time entries cannot be accepted, changed or cancelled except as allowed per move up clause below. Entries must be signed by owner or agent and submitted with fees. No telephone or fax entries can be accepted. **EXPRESS DELIVERY services must include SIGNATURE WAIVER permitting them to be left WITHOUT recipient's signature.**

ENTRIES ARE LIMITED to eight hours of judging time per day, per judge and will be taken on a first come, first serve basis (so get your entries in early). Regular Class entries, including the UDX class, will be given first priority followed by the Optional Titling Classes followed by the Non-Regular Classes.

Included in the entry fees: At every licensed or member club obedience trial a recording fee of \$0.50 and Service Fees of \$3.00 for a dog's first entry. There is a \$3.50 service fee for each additional entry by a dog. Non Regular Classes are excluded.

At every licensed or member club rally trial, a recording fee of \$ 3.50 shall be required for the each entry of each dog. These fees are collected by the show giving club and are paid to the American Kennel Club. (New AKC Rule Effective January 1, 2024)

Entry fees will not be refunded in the event the dog is absent, disqualified, excused by a Judge or Veterinarian, or barred from competition by the Trial Committee. If because of riots, civil disturbances, unsafe weather conditions or other acts beyond the control of the Club it is impossible to open or to complete the Trial, no refund of entry fees will be made.

Transfers (formerly Move-ups)

- After a dog earns a title, a transfer (i.e., from an obedience class to an obedience class or a rally class to a rally class) may be requested if, according to the owner's records, the handler and dog are eligible and the dog has completed the requirements for the title after the closing date of the trial in which the advanced entry is to be made.
- The request for a transfer must be in writing and presented to the trial secretary at least 30 minutes prior to the start of each trial.
- Transfers may be approved provided the class and judge are available, and the class has not reached its limit.

For a written request regarding a transfer for an ineligible dog and handler team from the "A" class to the "B" class at the same level, please refer to the AKC Obedience Regulations, Chapter 1, Section 16b

VACCINATIONS ETC. Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases and have appropriate vaccinations.

BITCHES that come into season after the closing date for entries may have the entry fee less \$5.00 per dog per class refunded upon written request of the owner or handler before the start

of judging on the day of the trial. Must have Vet note.

ATTENTION ALL EXHIBITORS

- ◆ Misconduct at hotels/motels may result in an Event Committee hearing.
- ◆ Exhibitors are responsible for picking up after their dogs at the OCOD/K-9OCJ Training Building and at hotels/motels. Your continued responsibility and respect allow hotels / motels to continue to work with K-9 Obedience Club Jacksonville, Inc. so we can provide you with the best venue possible. Please relieve your dogs in marked areas outside and be careful to not allow your dog to mark or urinate inside or on the buildings, trash cans and cars nearby. - (Variety) if you are entering a dog of breed in which there are varieties for show purposes, please designate the particular variety you are entering, i.e., Cocker Spaniel (solid color black, ASCOB, parti-color), Beagles (not exceeding 13 in., over 13 in. but not exceeding 15 in.), Dachshunds (longhaired, smooth, wirehaired), Collies (rough, smooth), Bull Terriers (colored, white), Manchester Terriers (standard, toy), Chihuahuas (smooth coat, long coat), English Toy Spaniels (King Charles and Ruby, Blenheim and Prince Charles), Poodles (toy, miniature, standard).
- (Event Class) Consult the classification in this premium list. If the event class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e, A or B division.
- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. These dogs should be listed as All American Dog and must include their AKC Number on the entry form and check the AKC No. box. Sire and Dam information shall remain blank for mixed breed entrants.
