DOCOF, 2018

So another DOCOF weekend is over. DOCOF stands for “Dog Obedience Clubs of Florida,” and exists as a “club for clubs” to give one grand competition on Labor Day weekend every year. The exhibitors compete as teams from the clubs, and at the end of the day the scores are tallied, and the clubs are ranked. It’s a great big match that is unique in the country; people actually move to Florida to be able to compete at DOCOF.

I’ve been doing DOCOF since about 1995 and can tell you some weekends are good, some are disastrous, many are simply forgettable. But some are successful not only for our club’s score but for the camaraderie we experience, and this year was one of those.

This year’s DOCOF was held at the Osceola Heritage Park in Kissimmee. We spent Saturday practicing in the rings we would show in on Sunday. One of the rules is that each club must provide either a morning and afternoon steward or one all-day steward. Thank you, Robin Wallen, who came along specifically to serve as K-9’s all-day steward. She brought Blue and they did get some practice time in the ring as well and exposure to a big, crowded, noisy trial atmosphere.

Each team is allowed 9 members; 3 dog/handler teams each for Novice, Open, and Utility. The lowest score for each class is dropped so only 2 scores in each class count. Also, a dog/handler may NQ in one exercise, but the team is allowed to keep the rest of the points earned. K-9’s team only had 2 dogs in Open (Diane Cohen and Isaac and Elaine Nabors and Lycan). We had 3 in Utility (Dianne Strickland and Saxon, Melissa Hess and Adam and me and Annie) but Melissa had to cancel due to a family emergency so that left Dianne and yours truly. Our Novice group was originally Diane Cohen and Isaac and me and Jack but THANK GOD Susan Howard said she would join the team with Winston to run in Novice. (Jack has his talents-Barn Hunt-and I love him dearly, but he has as much business in the ring doing Obedience as I have in the Operating room doing brain surgery!)

I was privileged to see Susan and Winston’s Novice run and correctly guessed they would score in the high 190’s. As it turned out they earned a 199 and High in Trial (the highest score of the approximately 250 dogs that showed that day!) It was an amazing accomplishment for Susan and huge honor for K-9!

But that wasn’t the only trophy we earned; Dianne Strickland and Saxon earned 3rd Place overall in Utility out of 56 dogs competing! Diane Cohen and Puff managed a nice qualifying score in Novice (at that point I scratched Jack’s name off the board) and although our other scores were not successful for every exercise we managed to gather enough points for **6th place out of 27 teams competing.**

So, K-9 Obedience Club can hold its head high.
